### Purpose

Coastal Nations Fisheries (CNF) is a transformative fishing company on the North Pacific Coast, collectively owned by eight First Nations—Gitga'at, Gitxaała, Haida, Heiltsuk, Kitasoo Xai'xais, Metlakatla, Nuxalk and Wuikinuxv.

The eight shareholder Nations have come together to exercise their ancient inherent rights and responsibility to self-determination and self-governance. This includes breathing new life into each Nation's jurisdiction, authorities, responsibilities and laws, as well as revitalizing and implementing their respective legal systems, customs and traditions.

Through their alliance, the Nations honour each other's holistic and integral relationship with the marine environment. Each Nation is committed to preserving healthy ecosystems that, in turn, support their communities through sustenance, and by contributing to economic wellbeing and social, cultural and spiritual practices.





### Vision

Vibrant and prosperous fisheries, sustainably harvested and managed, by our coastal shareholder Nations.

## Mission

To support shareholder Nations in the revitalization and stewardship of community-based fisheries and the development of a thriving boat-to-table, Indigenous-owned and sustainably operated commercial fishing company.



### What We Do

A 100% Indigenous-owned commercial fishing business, CNF is working to revive community-based fisheries and participation in coast-wide commercial fisheries for all shareholder Nations, restoring the stable livelihoods they provide for families.

Through the creation and reinvestment of commercial fishery revenue, CNF provides ongoing support and training opportunities for fishers in shareholder Nations, and helps to advance stewardship initiatives that will sustain healthy coastal ecosystems into the future.

#### **Community-Based Fisheries**

Support the revitalization of community-based fisheries led by each shareholder Nation.



Support Coastal Fishers

Support the creation of new jobs and income opportunities, improving economic, social and community wellbeing in shareholder Nations.



Build Capacity Through Training

Empower and support existing and new fishers through the training, certification and business planning that is necessary for success in coastal fisheries.

### Support for Coastal Fishers

Coastal Nations Fisheries is part of the implementation of the Fisheries Resources Reconciliation Agreement (FRRA), negotiated between the eight shareholder Nations and Canada, which includes financial capacity to support the participation of shareholder Nations in coastal fisheries.

Here are some of the ways that CNF works on behalf of shareholder Nations to deliver on economic opportunities set out in the FRRA:

Acquisition and fair distribution of licences, quota and vessels for the Coastal Nations Commercial Fishing company and community-based fishing fleets, based on the priorities of shareholder Nations.

Co-development of a loan-and-grant program with Vancity and the Native Fishing Association to facilitate Nation citizens in buying or making improvements to vessels and gear.

Work with partners, such as Vancouver Island University, Coastal Communities Network and BC Commercial Fishing Association, to deliver training and mentoring to new fishers.
